## FY 2025-2026 Budget Workshop

The Board of Trustees met in the Bulldog Board Room at 4:00 p.m. to conduct the FY 2025-2026 Budget Workshop. The following information was presented to the Board.

Proposed Budget for 2025-2026 with enrollment projections, trends, priority focus programs, and target groups. The 2025-2026 proposed budget provides revenues by location, resource allocations, and cost analysis by location.

HB8 Formula Funding comparison between FY25 and FY26 were presented. Included in the presentation were additional rules for FY25, actual outcomes for FY24, actual and forecasted outcomes for FY25, funding schedule with adjustment funding for FY25, and additional funding opportunities for FY26. The HB8 legislative change has the potential to impact 9 associate degree programs offered at Navarro College from being considered a credential of value for outcome funding.

Pro Forma information includes baseline projected revenue, resource allocation projections, revenue to expenses for FY25-FY30.

The workshop was for informational purposes only and no decisions or actions were taken. The workshop ended at approximately 6:00 p.m. and the Board recessed for dinner in the President's Dining Room with members of the Leadership Team.

## **Update on Enrollment**

Vice President Sina Ruiz presented to the Board the enrollment update. Compared to last year at this time Summer I credit hours are up 14%, Summer II are up 13% and has achieved its goal. Fall 2025 enrollment is up 18% and has achieved 49% of its goal. Continuing Education continues to do well with quarter 3 at 95% of goal, and quarter 4 at 43% of goal.

# **Finance and Operations**

#### May 2025 Financial Statement

Vice President Teresa Thomas presented the May 2025 Financial Statements to the Board for approval.

The statement of budget changes ending May 2025 shows amendments of \$102,325.00. This amount consists of a \$100,000.00 donation to the RV Tech Program and Cosmetology sales of \$2,325.00.

The sources of funds report show the percentage of budget earned for the E&G Fund year to date ending May 2025. Academic Student 95.28%, Continuing Education 90.18%, Local Appropriations 115.86%, State Funds 77.16%, Federal Grants 59.49%, State Grants 38.48%, Local Grants \$71.85%, and other Sources 61.64%.

The disbursement of funds for E&G shows expenditures increased by \$4.5 million compared to May 2024. The comparative summary of sources and disbursements shows total income of \$5.1 million and expenses \$4.5 million year to date ending May 2025. The E&G fund budget to actuals show \$7.1 million more to collect.

The available cash and cash equivalents as of May 31, 2025 are \$31 million and average monthly expenditure budget covered by available cash is 4.15 with an average of 4.08.

The motion to approve May 2025 Financial Statements were made by Trustee Loran Seely and second by Trustee Richard Aldama. The motion passed unanimously.

# Quarterly Investment Report for Quarter Ended May 31, 2025.

Vice President Teresa Thomas presented the Quarterly Investment Report for Quarter Ended May 31, 2025 to the Board for approval.

All CD's have matured and moved into TxStar Investment Pool. The ending book value as of May 31, 2025 is \$5.6 million. The recap of TxStar investment pool shows E&G at \$5.3 million and Student Financial Aid at \$230,000. The benchmark rate as of May 31, 2025 is 4.29%.

Pledged collateral by bank to secure cash and certificates of deposit for quarter ended May 31, 2025 are deposits of \$24.2 million, TxStar \$5.59 million, and FDIC insured at \$750,000.

The motion to approve the Quarterly Investment Report for Quarter Ended May 31, 2025, was made by Trustee John Paul Ross and second by Trustee A.L. Atkeisson. The motion passed unanimously.
